

## **EUROPEAN BOOK PUBLISHING STATISTICS**

11 June, 2010

## **Executive summary**

The Federation of European Publishers (FEP) represents 26 national associations of publishers from the European Union and the European Economic Area Member States. The present survey is based on reports from the national book publishing associations, and on a further work of estimation and refining of data, for the year 2008.

Figures on the overall economic significance of the publishing industry refer to net publishers' turnover, i.e. the publishers' total revenues from the sales of books, not the total market for books (margin of booksellers or other retailers). They also do not account for revenues in terms of selling rights for translation, audiovisual adaptation, etc. In some cases, only data on market value was available; in such cases, average discount rates were applied to calculate an approximation of net turnover. Figures were rounded conservatively.

The total annual sales revenue of book publishers of the EU and the EEA in 2008 was approximately € 23.75 billion, according to the survey conducted by FEP; this represents a decrease from the last estimate of € 24.5 billion for 2007, but in very large part such decrease was only nominal, due to changes in exchange rates. The largest markets in terms of publishers' turnover in 2008 were Germany, followed by the UK, France, Spain and Italy.

A total of about 510,000 new titles were issued by publishers in 2008. The figure was taken from different sources, some of which included new editions or non commercial titles, and was rounded quite conservatively accordingly. There was an increase of an estimated 4% in the title output from the previous survey. European publishers held a total of over 6 million different titles in stock, the countries reporting the largest availability being the UK (over 2 million), Germany (around 1.2 million), Italy (over 600,000), France (over half a million) and Spain (almost 400,000).

The countries reporting the largest new titles output<sup>1</sup> were the UK (120,947), Germany (83,381), Spain (42,592), France (38,354) and Italy (36,409).

According to the report, a total of approximately 135,000 people were employed full time in book publishing in 2008, an amount slightly lower than one year earlier.

Beyond the individual figures, it can be noted that up to 2007 there was a clear increasing trend both in terms of turnover and of titles output, while in 2008 the title production kept growing while for turnover, adjusting for exchange rates effects, it was basically a flat year; the crisis therefore has had a lighter impact on publishing than on most other sectors. This analysis relies on the examination of more detailed data from a number of members that represent well over 80% of the total turnover and title production.
